7. Community Governance Review

The council noted that petition slips are on the March 2013 newsletter and that by kind permission voting boxes and petitions have been placed in the Village Shop and Ample Hamper and that the petition has been emailed to Ampleforth College.

8. Churchyard

- a) The council could not consider the arrangement with RDC about liability cover for cutting the grass as it had not been received.
- **b)** The council noted the negative response from Mr P Cresswell, RDC, following the council's request for a grant for cutting the churchyard grass.

c) The council noted that Special Expenses have not been introduced for 2013-2014 by RDC (26 February 2013, RDC Full Council budget meeting).

9. Police and Crime Plan Consultation

The council decided not to respond to the consultation from the Police & Crime Commissioner.

10. Common Shares

- a) The council noted that the clerk was informed by Kitching Walker Solicitors in February of the death of Mrs Todd, tenant of Common Shares 2 and 3, in November and resolved to seek professional advice.
- **b)** The council agreed that a request from Kitching Walker Solicitors to transfer Common Shares 2 and 3 to a member of the late Mrs Todd's family be referred to a solicitor.
- c) The council noted that notice has to be given of rent increases to the tenants of agricultural shares and agreed that the council's advisors look at the rents and tenancies for all the Common Share tenancies.

11. NYCC Archive and Ampleforth Parish Council records

- a) The council resolved to accept the terms and conditions of NYCC Archive.
- b) The council resolved to archive documents at NYCC as per the attached list. Endnoteⁱ
- c) The council noted that the clerk has not found any Ampleforth Parish Council title deeds when sorting out documents for archiving except 'Mrs D Wallinger Abstract of Title 1959' (copy for archive).

12. Deeds and Land Registry

The council resolved to seek legal and other assistance to check if the Common Shares and the Cemetery are registered with the Land Registry and to instruct a solicitor to assist with their registration if necessary.
